Privacy policy

The protection of your personal data is important to us. We process your data exclusively within the framework of the statutory provisions (EU General Data Protection Regulation, Federal Data Protection Act). In the following, we inform you about the most important aspects of data processing within the scope of our business relationship.

Collection and processing of data

We process those data that you provide to us as a customer for the implementation of pre-contractual measures and upon conclusion of the contract.

The data processing is carried out for the following purposes:

Within the scope of our business relationship, at least with the help of partial or predominant automation (e.g. e-mail correspondence, index card programs) and in the form of archived text documents (e.g. correspondence, notices, findings, personalized invoices), the data provided by you are processed in order to be able to carry out pre-contractual measures and fulfill the contract.

Legal basis for data processing

Data processing is carried out on the basis of Art. 6 Para. 1 lit. b of the DSGVO (contract initiation and fulfillment). For the conclusion and execution of an examination/treatment contract and in order to be able to process it to your complete satisfaction, we need your data (name and residential address). In addition, the data processing is based on Art. 6 para. 1 lit. f of the DSGVO (legitimate interest in marketing and advertising) or Art. 6 para. 1 lit. a (consent). We would like to provide you, as interested parties, with up-to-date and targeted information about our services, in particular in the form of vaccination reminders and projects (especially the organization of an "open day").

Use of data

We use your data only for the execution of the contract, to answer your inquiries, for accounting and billing purposes and for technical administration. Your data will be deleted when it is no longer required to fulfill the purpose for which it was stored, or when storage becomes inadmissible for legal reasons. Data for billing and accounting purposes are not affected by a request for deletion.

Data cannot be deleted if legal provisions oblige us to retain or store it (e.g. X-ray images).

Your rights

You generally have the right to information, correction, deletion, restriction of processing, data portability, revocation and objection. If you believe that the processing of your data violates data protection law or your data protection rights have been violated in any other way, you can complain to the supervisory authority. This is the State Data protection Authority of Rhineland-Platinate, Hintere Bleiche 34, 55116 Mainz.

Declaration of consent to the use of data for further purposes
